**The application process is as follows:**

- You submit two applications to the Kortney Rose Foundation (KRF), acknowledging your commitment to the fundraising involved and to paying for your application fees to enter into the 2010 ING New York City Marathon.**
- Once your application is received KRF will be respond within 72 hours.**
- If accepted, The Kortney Rose Foundation notifies the New York Road Runners (NYRR) that we have accepted you on Team Kortney.**
- KRF will notify NYRR to send you an invitation to participate as a marathon runner on Team Kortney.**
- The invitation will instruct you on completing the necessary application and what the registration fees will be.**
- Once NYRR processes your application and fees we will inform you how to set up a fundraising page and other pertinent information.**

**We use Activegiving.com for our fundraising efforts for this marathon. This allows each runner to set up their own personal page and have supporters go directly there to donate. Everything is tracked for you so you are always aware of who has donated, in what amounts and what your total raised is.**
